Hearing aid dealers and audiologists look forward to this opportunity to view and compare new lines of equipment. The opportunity to visit with sales representatives away from the office setting in a relaxed atmosphere is a positive feature of the Trade Show.

Exhibitors will have 5-6 minutes to present their product to small groups of attendees and repeat the presentation as attendees move from booth to booth. Meeting attendees will get one hour of CE credits to encourage participation in the round robin.

The \$390 will include an eight foot draped table, company identification sign, and chair. Tables will be assigned on a first-come, first-serve basis. Space is limited, so please send the attached pre-registration form along with your check to the IHA office as soon as possible and **no later than April 15, 2024.**
